ICMPD would like to inform prospective applicants that the deadline of the Call for Proposals for “SME Support Grant Scheme for Job Creation” has been extended to the new end date of 27 September 2021, 17:00h (Vienna local time).

Except for the changes on the time extension, the Annex-H Information on The Tax Regime Applicable to Grant Contracts (Annex\_H\_Information\_on\_tax\_regime) which can be found in the Documents for Information zip folder, has also been updated.

Please see below the details of the changes in Call for Proposals documentation:

**(1) Call for Proposal Guidelines (file: ENHANCER Turkey SME 1. Call for Proposals Guidelines EN\_13072021.pdf) has been updated.**

The text of the Guideline of Applicants has been modified as follows:

- The line *`Deadline for Submission`* from the cover page of the Guidelines for Applicants “13 September 2021” has been replaced with “27 September 2021” as the new submission deadline.
- Under the headline *`Deadline for Submission of Applications`*, Section 2.3.4. of the Guidelines for Applicants, the following text has been deleted:

*“The deadline for the submission of applications is 13 September 2021, 17:00h (Vienna local time).”*

and replaced with:

*“The deadline for the submission of applications is 27 September 2021, 17:00h (Vienna local time).”*
