2. This will open a new screen which has four tabs titled 'Company Details', 'Business Classifications', 'Extra Details' and 'Company Categories'. You must work your way through each of these tabs ensuring you complete all of the yellow mandatory fields.

The 'Company Details' tab requires you to provide basic contact information for your company, to create a primary and, if applicable, a secondary user and create a password for each. Once the registration process is complete you can edit your account to add as many other users as you wish. The yellow boxes are mandatory details and the minimum information required to register.

3. The 'Business Classifications' tab allows you to link various categories of business to your company account. When a new project is issued, it will be linked to one or more

of these categories, so it is important to choose the most applicable categories to your business.

The best process for this is to leave the search box empty and click 'Search'. This will bring up a full list of all business classifications, simply click the blue + next to the category you want and it will be added to your account. To remove categories click the red \times in the table that appears below.
